- Nominee has made a major contribution or has achieved significant accomplishments in the volunteer fire service on a local, municipal, provincial, and/or national level. (more than local community)
- Nominee has demonstrated superior dedication to the volunteer fire service and has served as a volunteer firefighter for at least twenty (20) years.
- Nominee has been active in their provincial firefighters association.
- Nominee has demonstrated community impact through the fire service or other volunteer activities.

Nomination forms can be found on at www.cvfsa.ca or www.commercialsolutions.ca. The individual nominated is not required to be a member of the CVFSA. Anyone wishing to make a nomination who is not currently a CVFSA member need only download a membership form from www.cvfsa.ca, become a member and then nominate.

Only one award will be presented each year to one volunteer firefighter or fire officer.

Nominations for the 2010 year are now OPEN and will be accepted till March 6th 2010.
